History

TAABAR (registered under the Rajasthan Society Registrations Act, 1958) is a not for profit organization based in Jaipur (Pink City) of India. A modest beginning in the year 2006 with an informal idea to help the needy children, with the help of some like-minded friends. Formally, it came into existence in 2007 as a TAABAR Society. Since its inception in 2007, TAABAR's endeavour has been to extend helping hand to the children in difficult circumstances.

TAABAR aspires for a FREE, CARING Society for the children living in difficult circumstances, those who are in need of care and protection, underprivileged who are considered insignificant in most of the spheres of development and are more exploited and vulnerable.

Our Values



Child Care Institutions (CCIs)

TAABAR is operating an Open Shelter Home (Short Term Care) known as Bal Basera, and a children home (Long term care), registered under Juvenile Justice (Care and Protection of Children) Act, 2015, certified by Department for Child Rights, Government of Rajasthan.

- 580 Children in need of care and protection (Runaway, Missing, Child Labour) were received
- 411 Children re-united in families
- 149 Child laborers transferred to their states





Day Care Center

Day care center is a "multi-tasker project" of TAABAR. It is a center for education, health services, nutrition, community strengthening and acts as a "bridge" between the community and organization for its services and for building the rapport. Day care center is a space for children to explore their potential and unleash it with the help of proper guidance of the teachers. TAABAR is taking care of the out of school, neglected, children adolescent girls and children of nomadic communities through the intervention in slum areas of Jaipur.



- 113 Children were enrolled in schools
- 350 Children received pre-school education
- 1247 Children received after school support & educational support (tuition fee, books, uniforms etc.)
- 1423 Children received nutritional support
- 26 Children and youth received Skill building & talent support

Women Training Center (WTC)

Family strengthening is another thrust area of TAABAR. To meet the objective of family Strengthening, TAABAR is running a women training centre for women & girls in Khor Slum. The WTC is an intersection of economic independence, education rehabilitation & reintegration. The centre is imparting the skills of tailoring, art and craft, Mehandi & beauty therapy etc.

Mobile Library Van

Essentially, Mobile Library Van is a travelling hub for learning and discovery. Mobile library project called Libraries On the Very Edge, or LOVE, which aims to provide an informal and dedicated source of education to children and youth, aged 5 to 18 years old. These children live in slum areas or in outlying villages and have limited or no access to schools and other educational services that would otherwise be readily available in the city.

By bringing the library right to their doorsteps, TAABAR hopes to inspire children, youth, adults to develop a love for reading and studying and these children will eventually have the means to break out of the poverty cycle. It encourages and feeds a child's nascent hunger for information and knowledge, and give the nation's young a valuable opportunity to develop essential skills that will enhance their chances to improve their lives

Mobile Clinic Van

The TAABAR mobile clinic brings primary medical care by providing referrals, free treatment, medication and counseling on various health issues. The van works six days in a week, going to six different places in Jaipur namely Railway station, Kagdiwada, Luniyawas, Jhalana, Khor, Premnagar covering one place in a day. The van operates for two hours per visits to provide health care services free of cost. Total 27501 OPDs done in the reporting year.

Strengthening Child Protection Mechanism in Rajasthan

The project was commenced in 2014, with the aims of creating a safe and protective environment particularly for children in need of care and protection. The strategic focus of the intervention is to strengthen the existing response mechanism (of government) thereby developing operational partnerships with different departments, capacity building of different stakeholders and establishing best practices of care for broader replication. Convincingly after 5 years of the project TAABAR has account of numerous achievements, recognitions, partnerships with various stakeholders etc.

An external assessment of child care institutions run by TAABAR was accomplished.

Mr. Sanjay Gupta (Consultant) identified best practices as follows:

- 1. Various levels of child participation
- 2. Development of engagement plans for children
- 3. Theatre for change
- 4. Attempt towards end-to-end case



Media Workshop

TAABAR organized a one day sensitization workshop on "Role of Media in Protecting Rights of Children" for Media Representatives on 4 May 2018 in partnership with Child Resource Center, HCM RIPA, Jaipur with the aim of building linkages and developing dialogue between media professionals and other engaged in the area of child protection or child rights

Objectives of the workshop

- 1. Awareness on National and International instrument and guards of protecting child rights for ethical reporting
- 2. Discussing role of media in light of Children Acts (JJ Act, POCSO Act, Labour Act)
- 3. Sensitization on responsible coverage of child related issues
- 4. Stimulate discussion and mobilization among media professional



Moderating the session, Mr. B.L. Soni (IPS) ADGP, Police Head quarter Jaipur urged to the participants to break the culture of silence to culture of zero tolerance. Out of millions there are very few children who are able to break the silence and raise voices. He added that media can play a significant role to change the culture of silence into culture of zero tolerance. Media can expose success stories of those who dedicatedly working in the same field to generate awareness and motivating people to come forward for best interest of children.

Key Outcomes

- The panel discussion by eminent representatives of various departments and experts focused on several issues and challenges media and stakeholders face when it comes to analyzing role of media while reporting children issues under various children Acts.
- The speakers agreed that media houses can play an important role to protect, save, rehabilitated, reunite and reintegrate the vulnerable children, victims and at risk children.
- Media should resist itself from the temptation of sensationalize or exaggerated coverage on child issues whether is about sexual abuse, physical abuse, child labour etc.
- Collaboration, Reintegration and participation of media under child protection mechanism are utmost requirement to play an effective and realistic role by media in child care and protection.
- The workshop stimulated a need of public discourse, strategies for future and suggestions and guidelines for ethical reporting.

Child Labour Free Jaipur Initiative (CLFJ)

Thousands of children are working as child labourers in workshops in Jaipur. They are engaged in making bangles, embellished textiles and even polished stones for jewellery. The Child Labour Free Jaipur Initiative is embarking on comprehensive interventions to stop child labour in the Pink City. The CLFJ Initiative is a multi-stakeholder partnership with broad-scale support from state and district level governments, businesses, civil society organisations and local communities. It is supported by Children's Investment Fund Foundation, British Asian Trust, C&A Foundation and The Freedom Fund. The overall project goal is to reduce the number of children engaged in handicraft workshops across Jaipur city by contributing to a significantly increased number of children rescued from exploitation, and high-quality support for their recovery.

TAABAR as a partner, is shouldering up the responsibilities of post rescue care and protection of child laborers through shelter home, effective district level coordination and collaboration to address the issues of child labour, increasing capacity, understanding, and sensitivity among officials of various departments, creating child friendly environment and service delivery structure.



- TAABAR received 158 children rescued from different places, trafficked from Bihar, 145 handed over to the government of Bihar.
- TAABAR has been instrumental from rescue to till the repatriation of child laboures that is an exhausted and complicated exercise. During this period TAABAR liaise with many departments like police, child welfare committee, medical, legal, railway, RPF/GRP, Administration.
- TAABAR took initiative to ensure the compensation to child labourers under Rajasthan Victim Compensation Scheme 2012, submitted 32 files to District Legal Services Authority, 28 files has been approved. It is the first time in Rajasthan when child labourers will get the compensation under this scheme.
- TAABAR initiated the process of opening of bank account of child labourers so that children could get the money of compensation.
- TAABAR also submitted 45 Files to labour department to ensure the compensation under The Minimum Wages Act, 1948.
- Arts Based Therapy sessions, socio-psychological support is being provided to the child laboures.

Taabar Rangmanch

TAABAR got across 5888 people in various categories through the theatre performances of the children living in child care institutions. It is proud to mention that TAABAR Rangmanch is getting recognition by various departments like judiciary, police, INGOs etc. The performances of the children on various platforms are influencing the mindset of stakeholders and people.



Success Story

Shatrudhan is a 10 years old boy. He hails from Samastipur, a district in the state of Bihar. When he was brought to the shelter home. His face was swollen. He had injuries on his body. We quickly provided him food, arranged for medical help, and made efforts to make him comfortable. Shatrudhan told the counselor that his parents were no more in this world. He had been living with his elder sister in Milkhi village.

One day, a person named Nurul came to see his brother-in-law. Nurul was a resident of same village. He spoke to Shatrudhan's sister and brother-in-law for a long time. Two days later, Nurul brought him to Jaipur and put him to work in a bangle workshop. Shatrudhan added that everything was all right for a month, but soon after, Nurul started beating and torturing him. He beat him with an iron rod or whatever object he had in his hand. It became his daily routine.

Nurul was an alcoholic and beat him brutally when Shatrudhan asked him if he could connect with his sister and brother-in-law. He scalded him with a hot iron rod on his neck. Nurul sent him to sleep with older boys working in the same place. These boys sexually abused him. Despite working in the workshop for two years, he never received even one rupee of wages. While talking with the counselor at the shelter home, he expressed his desire to eat "dahi vada" (a common local food consisting of a deep fried donut made of lentils and placed in yogurt. Immediately, he was served the dish. He ate it like a baby dinosaur would. During the interaction with counselor, child told that he used to feel very much like to eat sweets, ice cream, etc.. But whenever he demanded for something to eat, he was beaten by Nurul. We immediately informed the Child Welfare Committee in Jaipur and requested to lodge a complaint, or "First Information Report," against the employer. Sodala Police Station came into action after receiving the complaint. On the basis of information received from the child, police prepared a report and headed to the identified workshop with a rescue team but Nurul had escaped. The police set up a trap with the help of landlady. Nurul was arrested after the efforts of few hour. The police booked him under the Juvenile Justice Act and other sections of the Indian Penal Code.

Since the child was physically abused we asked the police to obtain a recorded statement under Section 164 of the Criminal Penal Code (CrPC), but the police denied by saying that the statements by child labourers cannot be recorded under Section 164. With the collective push for policy change in motion, Taabar then approached the District Legal Services Authority and met the full-time secretary to make him aware of the child's case. The secretary, Mr. Satya Prakash Soni, immediately issued an order to record the child's statement under Section 164 of CrPC. Taabar staff showed this order to police officer-in-charge, who then promptly followed the order and submitted an application to the court for the statement to be recorded, which happened the next day. It was the first time that a statement of a child labourwas recorded under Section 164 of CRPC, paving the way for this strong new policy to lead to better evidence in legal cases against traffickers.

Shatrudhan went school up to 5th class. He left school due to the demise of his mother. The stepfather was not ready to keep with him so he left Shatrudhan's at his elder sister's place. After two years he started education again and showed remarkable performance. He wants to be an engineer in the future. He is very naughty and spontaneous. He shows tantrum in theater class, but he is a spontaneous performer. He also attended Arts Based Therapy sessions. During the sessions it was found that he needs to work with concentration and mindfulness. He like dancing classes, playing cricket. He also writes poems. Shatrudhan's health is good now.

Today, with proper medical treatment, counseling and exposure to education, outdoor play and crafts activities, Shatrudhan is doing well and happily living amongst the other children in the shelter home. He participates in each and every activity of the shelter home. The process of compensation, rehabilitation and filing charge sheet has been initiated. His health is being monitored by the doctor on a regular basis. Swelling of his face is fine. His wounds have healed.
